Awareness and Enforcement Promotes Safety



Growing reports, especially within the independent sector show that coffee machines are not complying with statutory regulations, increasing safety risks in the coffee industry.

We reached out to councils to offer a solution whereby we in this area.

We recently attended Rochdale council following a fantastic proactive approach led by Jackie Hall and her health and safety team. During the visit as part of this awareness and enforcement session we provided certificated PSSR refresher training, industry insights and an ongoing technical support mechanism.

As a result we are seeing an uptake can support their enforcement in Rochdale of compliance, we are now rolling these sessions out to councils nationwide on request.

What's CoffeeSafe been up to?

The HSE have published a detailed report (RR1177 - Risk control for small pressure vessels) into the risk/control surrounding "smaller" pressure systems in scope of the Pressure Systems Safety Regulations 2000 (PSSR) which includes, as a lead, coffee machines.

CoffeeSafe have worked to ensure this important safety research report reaches a wider audience as possible.

The report is supported by some very extensive investigation work whereby they purchased several coffee machines new and old to better understand their design standard, protective/control circuits and mechanical integrity prior to performing forced over pressurisation of them to the point of explosion with devastating results.

The HSE therefore concluded that PSSR must be applied in full to in scope coffee machines in order to reduce the risk via the control measures the Regulations/ ACoP(L122) set out.

The research highlights the importance of the requirement of examinations under the WSE and emphasise the need for the protective device/ control systems to be included within the WSE and therefore examined as part of the full pressure system examination.



These audits driven by the CoffeeSafe "Code of Conduct" provide a robust quality assurance check against our certified WSE and PSSR.


